<p><u>Term Commitment</u></p>	<p>You acknowledge and agree that you are entering into a new twenty-four (24) month term commitment for a Required Minimum Programming Package (as defined below) or a higher-priced programming package (the “Term Commitment”). This new Term Commitment begins on the date you accept this offer and will end after twenty-four (24) months of active DISH service.</p>														
<p><u>Early Termination Fee</u></p>	<p>If prior to the end of your new Term Commitment: (A) your DISH service is disconnected for ANY REASON (for example, and without limitation, if you cancel your DISH service because you move to a location where you cannot receive your DISH service) and all programming and other prices, fees and charges for your new Term Commitment have not yet been paid in full, you agree to pay, and DISH will automatically charge, an early termination fee to your DISH account or your Qualifying Card (as defined in your Promotion Agreement), at DISH’s option. The early termination fee will be prorated by multiplying \$20 by the number of months remaining in your new Term Commitment.
